JUDGMENT

1 This action came on regularly for trial on March 10, 1997, in Department 42 of the  
 2 Superior Court, the Honorable Vincent P. Di Figlia presiding; the plaintiffs and cross-  
 3 defendants appearing by attorneys Brian D. Monaghan, Michael A. Conger and Terrance  
 4 J. Rizzo and the defendants and cross-claimant appearing by David C. Bohan,  
 5 Christopher D. Liguori and Daniel J. Winters.

6 A jury of 12 persons was regularly impaneled and sworn. Witnesses were sworn  
 7 and testified. After hearing the evidence and arguments of counsel, the jury was duly  
 8 instructed by the court and the cause was submitted to the jury. The jury deliberated and  
 9 thereafter returned into court with its verdicts which are attached hereto (Tab #1 are the  
 10 verdicts on the plaintiffs' claims and Tab #2 are the verdicts of the cross-complainant's  
 11 claims) and incorporated herein.

12 It appearing by reason of these verdicts that the following plaintiffs are entitled  
 13 to judgment against defendants General Dynamics Corporation and Arthur Veitch as  
 14 follows:

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that these plaintiffs have and recover from defendants General Dynamics Corporation and Arthur Veitch the sums as specified above, with interest thereon at the rate of ten percent (10%) per annum from May 1, 1997, the date of the jury's verdicts, until paid.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that plaintiffs have and recover costs and disbursements against defendants General Dynamics Corporation and Arthur Veitch in the amount of \$ \_\_\_\_\_, together with interest at the rate of ten percent (10%) per annum from \_\_\_\_\_, 1997, until paid.

It further appearing by reason of these verdicts that defendant James Haygood is entitled to judgment against all plaintiffs.

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that plaintiffs take nothing from defendant James Haygood.

1 It further appearing by reason of these verdicts that defendants General Dynamics  
2 Corporation, Arthur Veitch and James Haygood are entitled to a judgment against  
3 plaintiff Irene Alisea Fretz.

4 NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that  
5 plaintiff Irene Alisea Fretz take nothing from these defendants.

6 It further appearing by reason of these verdicts that the cross-defendants Melanie  
7 Argo, Michael L. Baffone, George R. Bell, Richard De Luca, Kathleen Garcia, Hector  
8 J. Garcia, Michael J. Giorgetta, Neal C. Haas, Robert Hansen, Beverly Harman, Robert  
9 J. Henetz, Dennis Honeycutt, Christopher Lore, Dennis Moore, Donald H. Naish, Robert  
10 B. Porter, Timothy Richardson, Domingo Sanchez, Donna L. Shuffler, Printes L. Smith,  
11 Richard C. Smith, John H. Wines and Steve Winters are entitled to judgment against  
12 cross-complainant General Dynamics Corporation.

13 NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that  
14 cross-complainant General Dynamics Corporation take nothing from these cross-  
15 defendants.

16  
17 **Voluntary Dismissal of Fraud Claims of Individual Plaintiffs**

18 During the trial, and at the request of the plaintiffs, the following plaintiffs  
19 dismissed their fraud claims (counts IV, V, and VI of the Plaintiffs' Second Amended  
20 Complaint, filed October 6, 1995): (1) Alberta Danish; (2) Irene Fretz; (3) Henry Jordan;  
21 (4) James McBride; (5) Dewey Nelson; and (6) Jack Sinnott.

22  
23 **Voluntary Dismissal of Defendant Norm Pearl**

24 During the trial, and at the request of the plaintiffs, all plaintiffs dismissed their  
25 entire case against defendant Norm Pearl.

1  
2 **Voluntary Dismissal of Punitive Damages Claims Against**  
3 **Defendant James Haygood**

4 During the trial, and at the request of the plaintiffs, all plaintiffs dismissed all  
5 punitive damages claims against defendant James Haygood.

6  
7 **Voluntary Dismissal of Fraud Claims Against Defendant Ken Lake**

8 During the trial, and at the request of the plaintiffs, all plaintiffs dismissed all  
9 fraud claims (Counts IV, V, and VI of the Second Amended Complaint, filed October  
10 6, 1995) and punitive damages claims against defendant Ken Lake.

11  
12 **Nonsuit as to the Interference Claims Against Defendant Ken Lake**

13 At the conclusion of the plaintiffs' case, at the request of defendant Ken Lake, the  
14 Court granted his motion for nonsuit as to the interference claims against him (Counts  
15 II and III of the Second Amended Complaint, filed October 6, 1995). Accordingly,  
16 pursuant to California Code of Civil Procedure §581c, subdivision (b), the plaintiffs shall  
17 recover nothing against defendant Ken Lake.

18  
19 **Nonsuit as to Plaintiffs Alberta Danish, James McBride and Dewey Nelson**

20 At the conclusion of the plaintiffs' case, at the request of the defendants, the Court  
21 granted defendants' motion for nonsuit as to the interference claims (Counts II and III  
22 of the Second Amended Complaint, filed October 6, 1995). Accordingly, pursuant to  
23 California Code of Civil Procedure §581c, subdivision (b), the plaintiffs Alberta Danish,  
24 James McBride and Dewey Nelson shall recover nothing against any defendant.

25  
26 **Defendants' Motion for Summary Adjudication Granted as to**  
27 **Count I (Violation of Civil Rights)**

28 On November 5, 1996, on defendants' motion for summary adjudication, the court



1 granted the motion as to Count I (Violation of Civil Rights). Accordingly, pursuant to  
2 California Code of Civil Procedure §437c, subdivision (f), the plaintiffs shall recover  
3 nothing against any defendant on Count I of their Second Amended Complaint.  
4


5 **Demurrer Granted as to Cross-Complainant's First Cause of Action**

6 On August 9, 1996, on cross-defendants' demurrer, the court sustained to demurrer  
7 as to Cross-complainant General Dynamics Corporation's First Cause of Action (Breach  
8 of Fiduciary Duty) of the Second Amended Cross-Complaint, filed May 17, 1996.  
9 Accordingly, pursuant to California Code of Civil Procedure §430.30, the cross-  
10 complainant shall recover nothing against any cross-defendant on Count I of their  
11 Second Amended Complaint.
